The Educational Note

By the late 1800s, most states had mandatory school-attendance laws ... but U.S. Treasury officials decided to extend education beyond the classroom with a new series of "Education" paper money.

The Education Series included \$1, \$2, and \$5 Silver Certificates, dated 1896 — all redeemable in silver dollars. A \$10 "Educational" note was also planned, but never made it into circulation.

Many collectors consider the "Educational" dollar bill America's most attractive note. It's ornately engraved, and features the symbolic figure of "History," dressed in Grecian robes, with her right hand around a boy's waist. Her left arm is extended, and her hand points toward a book that's open to the Constitution. In the background are the Potomac River, the Washington Monument, and the Capitol.

The names of nearly two dozen prominent Americans are encircled by wreaths and form a border for the design. Among them are Daniel Webster, Robert Fulton, John Marshall and Nathaniel Hawthorne. The other side of the dollar bill has portraits of George and Martha Washington, separated by a large number "1," to indicate the denomination. This led some punsters to complain that no one should ever come between George and Martha.

Famous illustrator Will Low completed a preliminary sketch of "History" in May of 1894. His finished painting of "History Instructing Youth" is now displayed at the Bureau of Engraving and Printing in Washington. That's where engraver Thomas Morris copied the artwork — with minor changes — for the dollar bill.

More than 50 million of the notes were issued, but in 1899 the "Educational" series gave way to new designs. Why did the experiment fail? Mainly because of objections to the undraped female figure that symbolized "Electricity" on the \$5 bill.

TWO NEW ANA GOVERNORS JOIN NEW **PRESIDENT AND VP ON BOARD** — A new president and vice president, and two new and five incumbents have been elected to the ANA nine-member Board of Governors with 8,681 ballots cast in the biennial election. H. Robert Campbell of Salt Lake City, Utah, who ran unopposed, was elected president, and Helen Carmody-Lebo of Huntington Beach, California, and Logansport, Indiana, who also ran unopposed, was elected vice president. New Board members are Patricia A. Jagger and Alan Herbert. Incumbents re-elected are Thomas G. Hallenbeck, Kay Edgerton Lenker, Gary E. Lewis, Anthony J. Swiatek and John W. Wilson. Vice President Scott Travers and Governor Will Rossman, who both served two terms, did not seek reelection. Board members are limited to 10 years of service or five, two-year terms.

Campbell, a 15-year life member of the ANA, has served as an instructor at the Association's Summer Seminars, is a consultant for the ANA Authentication Bureau, and is a past club representative, district delegate, regional coordinator and National Coordinator of the Association's Representative Program. His experience as member of the Board since 1997 will help him lead the Association into the next century.

ANA OFFERS UNIQUE CALENDAR MEDAL FOR MILLENNIUM — The ANA is offering a bronze medal, featuring the ANA's lamp of knowledge logo on the obverse and a 2000 calendar on the reverse. The Hoffman Mint, a private minting firm in Carmel, California, that struck the ANA's Anniversary Convention medals this year, produced 1,000 of the 3-inch calendar medals for the ANA. "With the new millennium just around the corner, we thought some of our members might like to have this special keepsake medal," says ANA MoneyMarket Manager Rudy Bahr. "Each medal is packaged in a nice gift box along with a wood stand." The medals are \$39.95 each, plus \$5 shipping and handling. ANA SHOW IS A SOLID SUCCESS — The ANA 1999 World's Fair of Money in Chicago, hosted by the Chicago Coin Club (CCC), was a great success. More than 9,500 people came through the doors of the Rosemont Convention Center in five days, with 1,100 attending on Sunday, August 15. A record-number of new members (344) signed for the convention.

Film crews from the Discovery and History Channels set up on the bourse during the show. The Discovery Channel is preparing a feature on coins and minting and took advantage of the 19 nations represented on the Mint Mile. The History Channel focused on the first public display by Sotheby's auction house of California Gold Rush treasure recovered from the 1857 shipwreck of the S.S. Central America.

Philip N. Diehl, director of the U.S. Mint, discussed the 50 State Quarters Program, calling it "the most popular collectible product in a generation." He also discussed the Mint's newly launched H.I.P. (History in your Pocket) Pocket Change web site (www.usmint.gov/kids), an online learning community aimed at teachers and children, kindergarten to 8th grade.

Thomas A. Ferguson, director of the BEP, said this is "an exciting time" to be at the BEP. He anticipated more changes in the look of Federal Reserve notes within the first 10 years of the next century, to counter the everchanging technology that aids counterfeiters.

The ANA Education Department hosted nearly 50 hours of free programming, including a standing-room-only discussion on the authenticity of western American Assay bars reportedly produced during the California Gold Rush; Boy and Girl Scout merit badge workshops; and the annual World Series of Numismatics — won this year by the team of Tom De Lorey and Harlan Berk. A new educational feature was the "Treasure Trivia Game" for students age 6 to 18. More than 300 participants assured the game's continuation in the future.

Twenty-one sponsors and 140 patrons contributed a record \$77,500 to support the convention. Title Sponsors eBay, Inc., Krause Publications and Numis-matic Guaranty Corporation each donated \$10,000.

The newly elected ANA Board of Governors, with H. Robert Campbell as president and Helen Carmody-Lebo as vice president, was sworn into office at the banquet. The Franklin Mint gave out medals to all who attended the banquet, reviving an old tradition that will be continued at ANA shows.

HALLENBECK RECEIVES FARRAN ZERBE AWARD — Kenneth L. Hallenbeck, a professional numismatist and this year's Farran Zerbe Memorial Award recipient, is purely, plainly, absolutely a collector. "I like neat stuff, and I just love collecting," Hallenbeck says in the cover story in the August *Numismatist*.

Nearly six decades after he first took an interest in numismatics and despite his many successes, the 67-yearold coin dealer is humbled by his selection as the 1999 recipient of the Farran Zerbe Memorial Award for Distinguished Service — the highest honor the ANA bestows. "I never thought I would receive this award," Hallenbeck says. "All my work for the ANA and for numismatics was done not to receive awards, but because I love this hobby." Hallenbeck was honored at the Awards Banquet August 14 at the Chicago Convention.

As vigilant and relentless as he is in his own collecting pursuits, Hallenbeck is just as aggressive in his storefront business and in promoting the hobby and the ANA. "There is a synergistic benefit of having worked with and for the ANA," he says, based on his experiences as a staff member, officer and volunteer. A member of the ANA Board of Governors for 16 years in three separate stints, including two years as president from 1989 to 1991, Hallenbeck served as museum curator from 1977 to 1983. He continues to volunteer his services in a variety of capacities, including assistant treasurer.

ANA REACHES SETTLEMENT IN LAWSUIT — The ANA has reached a settlement with former ANA Executive Director Peggy A. Hofmann and former Chief Financial Officer Wayne S. Abraham to resolve all matters related to their employment and the lawsuit they filed against the ANA. "While the ANA believes it would have prevailed had the matter gone to trial, the cost of doing so, both in staff time and legal fees, could not be justified," says ANA Interim Executive Director Edward C. Rochette.

The settlement payment totals \$66,098.75, with Hofmann receiving \$19,971.61 (before taxes) and Abraham receiving \$18,063.59 (before taxes). The remaining \$28,063.55 will pay attorneys' fees. "The vast majority of the money needed to settle these claims came from the ANA's insurer," Rochette says. "The ANA's only monetary contribution was payment of its deductible."

Details of the settlement are available in the August 1999 issue of *The Numismatist* in the column "Developments on the Legal Front," which has been appearing since May. "Now that this matter has been resolved," Rochette says, "the Association can turn more of its attention to its mission of numismatic education. While the Superior and Stack's lawsuit still is pending — and will take additional time and resources to address — the ANA is hopeful it too will be resolved in a positive manner, allowing the Association to constructively work with all its members for the advancement of numismatics."
