President's Message by Scott Loos

With the new year upon us, why not consider a commitment to numismatic education? Many opportunities are available both locally and nationally ... here are a few possibilities:

National Coin Week - April 21-27, 2002 is the 79th Annual ANA National Coin Week, a time for individual collectors, clubs, and dealers to educate the public about the coin collecting hobby. It's a time for numismatists to go into classrooms, speak before civic groups or set up an exhibit. But, most of all, it's a time to let the world know that collecting coins can be educational, inexpensive and fun. The NCW theme for 2002 is "Faces of Time," focusing on the people whose portraits have graced coins and currency through the ages. Participation in NCW also has its rewards through both the PNNA and the ANA. The PNNA will again award prizes to the clubs in the PNNA territory that best promote NCW (\$100 for first place, \$75 for second place and \$50 for third place). The ANA is also offering two full scholarships to Summer Seminar in Colorado Springs. (See page 6.)

ANA Summer Seminar June 29-July 12, 2002. The ANA Summer Seminar is held on the campus of the Colorado College in Colorado Springs. Session I dates are Saturday, June 29, to Friday, July 5; Session II, Saturday, July 6, to Friday, July 12, 2002. Summer Seminar is an opportunity for numismatic scholarship and camaraderie offering students a wide and varied selection of week-long courses suited for anyone from the curious beginner to the most advanced numismatist. Some financial aid is available for both Adults and Young Numismatists who are active in the hobby. The upcoming PNNA convention May 3-5, 2002 will also offer a variety of numismatic theatre presentations, educational exhibits, Young Numismatist events, and regional meetings of several national numismatic organizations. All events will be listed in detail in the 2nd

2002 PNNA Convention by Dick Billings

Preparations continue at this time with lots of positive things happening. The 2001 floor plan included a total of 72 dealer tables. Within a month after the close of this year's show we knew we would need to expand that floor plan. The revised plan for 2002 includes 90 dealer tables and, as of Dec 17, I'm pleased to report that 84 of these tables have been sold. This means that 5 months prior to "show time" there are only 6 tables left available to dealers which our bourse chairman, Scott Loos, and I are confident will be sold well before April. Even though we continue to hear some discouraging news on the economy, there is reason to look for some light at the end of the tunnel by early spring.

Several improvements have been added to the prior show agenda due in large part to dealer comments:

- 1. Three new A-frame street signs will be in place (along with the one we already have) to help newcomers find the building.
- 2. We are coordinating a more intensive ad campaign in the trade journals as well as the Puget Sound area newspapers.
- 3. We have extended an invitation to John Wilson, ANA President, to attend. Although we have received no commitment yet, we are hopeful.
- 4. ANA "roving VP," Walt Ostromecki, will be in attendance again this year.
- 5. We are exploring ways of cooperating with the Puget Sound area Boy Scouts to enable scouts who are working on a coin collecting Merit Badge to benefit from PNNA participation in their program.
- 6. The bourse tables will be individually topped and draped to enable ease of last minute adjustments.

Things are going well and I'm starting to get excited! See you in May!!

2002 DUES ARE DUE

PNNA dues are assessed annually in January. Please send your dues to the secretary, Joe Boling, using the envelope enclosed. Individual dues are \$10; family groups and clubs are \$15. Individual life membership is \$200 (there is no club or family life membership category). If you believe you are already paid for 2002, check the mailing label on this issue of *The Nor'wester*. Members not paid by convention time will not receive *The Nor'wester* after that date.

Exhibits at the 2002 PNNA Convention

Exhibits must be in place by noon on Saturday 4 May to be eligible for awards, which will be announced at 4:00 PM. We would prefer to have your exhibits in place on Friday, so that visitors to the convention can view and learn from them. If you want to use PNNA cases, you must send an application to Larry Rowe by 26 April so that those cases can be available. Use the form enclosed to apply for exhibit space and exhibit cases (send to Larry Rowe, PO Box 61621, Vancouver, phone 360-573-9827; WA 98666; medalman@paclink.com). Remember that the PNNA best of show winner receives \$200 in assistance to take the winning exhibit to the ANA anniversary convention in the same year.

The complete exhibit application is four pages long, just like ANA's. Pages 2-4 are only needed if you intend to have someone else place or remove your exhibit or if you are a multiple winner of first place awards at previous PNNA conventions. If you think you need the last three pages (not included here to save postage), ask for a complete copy of the rules from the secretary at the address in the letterhead. There are several references to specific parts of the rules in the PNNA application; if you have a copy of the ANA rules, you can determine what those references are without having the PNNA rules in hand.

Best-of-Show – Byron F. Johnson, Jr. Memorial. Best exhibit of tokens or medals – C. E. "Hepp" Heppner Memorial.

Class 3 – Tokens, medals, and decorations.

Class 4 – World coins and paper money.

Class 5 – General or specialized.

Class 6 – Pacific Northwest numismatic material.

Non-competitive exhibits No specific awards.

Exhibits at the ANA 2002 Spring Convention

The ANA early spring convention in 2002 will be in Jacksonville, Florida. The dates are 7-9 March (Thursday-Saturday, no Sunday hours). If you are interested in exhibiting there, write to ANA headquarters (attention Rachel Irish) and request the exhibit rules and application. The case limit for spring shows is completely different from summer shows (up to fifteen cases if you show only one exhibit), which provides an opportunity to show the large exhibit you have always had in the back of your mind. Plus, the best-of-show award in the spring show is the Franklin Mint medal, a five-ounce 14k gold medal. APPLICATION DEADLINE IS 11 FEBRUARY.

Exhibits at the ANA 2002 Anniversary Convention

If you want to exhibit at the ANA anniversary convention in New York in August, ask ANA for an exhibit application now (see the information above about how to apply). THE APPLICATION DEADLINE IS 3 JUNE 2002.

A Talking Coin by Joseph Kleinman

Many of us involved in ancient numismatics wonder what it would be like if our coins could talk, to speak to us of their travels and experiences. No doubt they did much the same things that our modern currency does. Pay for food, lodging, clothing and perhaps transportation. For sure they were brought into pagan temples and paid for sacrifices to various gods and goddesses. Let us now examine a coin of an individual who's life still has an impact on us to this very day.



The coin is a Silver Tetradrachm of no less a personage then Alexander the Great. On the obverse of the coin is the head of Alexander posing as the demigod Herakles or Hercules as the Romans would have called him. Why Hercules? Alexander considered himself to be a god, Herakles was the last son of Zeus king of the gods thus the connection. How do we know that the head is that of Alexander? Hercules was often depicted as a mature man having a beard, here we see a beardless youth. Additionally, the depiction closely resembles sculpted busts of Alexander as well as other coin types that make no pretension as to who the subject is.

The reverse of the coin is of equal interest. We see the god Zeus seated on his throne holding an Eagle, his companion bird. This particular reverse type may very well be a representation of one of the "Seven Wonders of the World," only one of two shown on ancient coins. The master sculptor Phidias created a statue of Zeus in Ivory and Gold which was known throughout the ancient world. This statue was set up at Olympus although it may have been moved to Athens. Behind Zeus is the inscription "Alexander."

To the ancients, no more had to be said.



Scarce Token Found in Nevada Ghost Town

Recently, a gentleman named Joe Caruso wrote to inquire about a token found in the ghost town of Wonder, Churchill County, Nevada, which was an active mining town from 1906 to 1919. Although the token was found in Nevada, it was issued by The Bodega in Spokane. (See picture.) This token is listed in Al Erickson's book *Washington State Trade Tokens*, and is quite scarce, with only 3 or 4 pieces reported, based on a limited survey of serious collectors at the time the book was written (a couple of years ago). The token is not necessarily valuable because there are many other tokens from Spokane and most collectors collect by town, but nonetheless it is extremely interesting.

The Bodega was likely a tavern, and Bodega also operated a wine company in Spokane, which also issued a token. Anyone who has more information about the Bodega tokens is requested to contact the editor.

American Numismatic Association News

ANA STARTS ELECTRONIC NEWSLETTER FOR **YOUNG NUMISMATISTS** — "Your Newsletter," an electronic communication device designed for Young Numismatists (YNs), has been launched by the ANA. "We were looking for a way to improve communication with YNs on an informal basis," says ANA Education Director Gail Baker, who is spearheading the project. "Many young collectors are very conversant with the Internet and E-mail, and we think this weekly newsletter is right up their alley." Baker notes that the electronic publication, named by long-time YN advisor Larry Gentile Sr., is designed to keep YNs up-to-date on projects, events and activities offered by the ANA and its member clubs. It also provides a forum for exchanging ideas, interests and stories, and includes games, quizzes and opportunities to earn "YN Dollars" that can be spent at special auctions held for young numismatists every summer.

"Your Newsletter is a cooperative information device," Baker adds. "All young collectors and adults who work with YNs can have the newsletter E-mailed directly to them, or they can read it on the ANA's web site (www.money.org/ynnewsletter.html)." The YN newsletter is intended for personal or private use only.

ANA REVAMPS MEDIATION PROCESS — To better serve members, the ANA has updated, codified and redefined its mediation process. Under the new process, which took effect on October 1, 2001, ANA members and non-members can seek resolutions to problems, with all complaints handled first by a newly formed Mediation Committee composed of five past members of the ANA Board of Governors. The committee will have the authority to impose disciplinary measures against those found in violation of the ANA's bylaws or codes of ethics. Appeals will be heard by the Board of Governors, which retains the sole authority to suspend or expel members.

Those seeking resolution through the mediation process generally must file complaints within 90 days of the alleged violation. The ANA also may file a complaint without waiting for an individual to take action.

NCW PROMOTERS CAN WIN SCHOLARSHIPS -

The ANA is offering two full scholarships to an ANA Summer Seminar at the Association's headquarters for the best promotions of the 79th observance of the National Coin Week, April 21-27, 2002. This year's National Coin Week theme is "Faces of Time," focusing on the people whose portraits have graced coins through the ages, according to ANA Education Director Gail Baker.

"During National Coin Week 2002, the ANA wants people to pay attention to their money and the faces

looking back at them," Baker says. "With the United States Mint issuing fresh 50 State quarter designs every 10 weeks, people everywhere are thinking about the images on our money. Even members of Congress have expressed enthusiasm, asking numismatic hobby leaders for ideas, and officials at the United States Mint are looking into coinage redesign.

"But going far beyond an old item's collector value," Baker adds, "holding a coin from 50, 100 or even 1,000 years ago can begin an exciting journey of discovery into the honor, recognition, politics and power behind the face that appears on the small piece of round metal."

The Association is encouraging its members to join in the National Coin Week celebration by offering two full scholarships to a future ANA Summer Seminar.

Some activities collectors can do during NCW are:

- Design a web page exhibiting the faces on coins of yesterday and today.
- Present a talk on the people behind the portrait on a coin - the person who is portrayed and the artist who created the image.
- Visit the U.S. Mint Web site www.usmint.gov to see the faces that appear and will appear on circulating, commemorative and bullion coins.
- Mount a National Coin Week exhibit at a library, bank or school.

One scholarship will be awarded for the best NCW display mounted at the Association's National Money Show in Jacksonville, Florida, March 7-9, 2002. The other full scholarship will be given to the collector or coin club who submits a report of the best and most innovative way in which they promoted National Coin Week and the theme "Faces of Time."

CLASS SCHEDULE AVAILABLE FOR ANA SUMMER SEMINAR — Ten new classes and eight new mini-seminars are included in the just-completed course catalog for the ANA's 34th Annual Summer Seminar, June 29 to July 12, 2002 at ANA headquarters on the Colorado College (CC) campus.

"The coming Summer Seminar again promises to be a great one," Education Director Gail Baker says. "We have scheduled 32 classes and 11 evening miniseminars, plus evening bull sessions and tours. Many of the classes will fill up quickly, so I encourage all interested students to register as soon as possible."
