Puyallup Fair Volunteers Needed

Eric Holcomb has taken over from Joe Boling as the PNNA's Puyallup Fair Hobby Hall volunteer coordinator. Volunteers are needed to work 51 four-hour shifts (3 per day for 17 days, September 9-25) at the Hobby Hall coin collecting table, greeting the public and presenting a positive image of our hobby. PNNA offers nice awards for winners, and monetary awards to the best of show winner to advance their display to ANA competition. PNNA offers space at each convention for displays. So why are there not more displays? Is it because they do not have a high sense of priority? Is it due to the rather complex application form? Is it because the awards do not mean much anymore? An exhibit by J. "Hepp" Heppner Award) and Best of Show (the Byron F. Johnson, Jr. Award). An excellent job, Eric.

An exhibit by Susan Billings entitled "Chasing Alcoholics Anonymous Founders Day Conference Tokens" won first place in the "Specialized" category.

These were the only competitive exhibits entered this year. I hope you see my concern.

A non-competitive exhibit by Les Copan of "Canadian Commemorative Silver Dollars" was on display, as well as the club collection of PNNA Memorabilia brought by Joe Boling.

Some local historical rambling by Tom Sheehan

I just moved into an office in Edmonds and brought in much of my collection of numismatic literature. It is interesting what I found as I sorted through it in an attempt to get organized. (Being organized may be a fantasy.)

The first thing to catch my eye was an orange card labeled Seattle Coin Club Roster 1959. The president at that time was Lawrence W. McCabe. I never knew him but I do know his wife Alice McCabe. She is now a life member of the Seattle Numismatic Society which is the name the club took after its merger with the University Coin Club. It is interesting that we almost had another club with that name. I found a letter from Ed Rochette to Byron Johnson that discusses the potential forming of a new club with the name of the Seattle Numismatic Society in 1976. All of its potential members were also members of the ANA.

Another officer name that I knew was Hildur Garlinghouse. I joined the club some time later but recall her and understand that she and/or her husband collected gold. She has since passed away. As has Clarence E. Heppner. "Hepp" had a shop in downtown Seattle on Third Avenue. His main interest was tokens and stamps. {Editor's note: the C.E. "Hepp" Heppner Exhibit Award is named in his honor.}

The membership numbered ninety-six. Quite a large number compared to today's membership. It is interesting that everyone's address and phone number was listed. Not something that would happen in today's world. The club had members in Winslow, Tacoma, Aberdeen, Bellevue, Moses Lake, Wenatchee and Chehalis!

Life member number 1 was Paul Fouts. I recall buying Indian Head Cents from him as a kid. I would pick through a cigar box and pay 5 cents each for what I found. Ben Gorlick was another dealer. His business was the Bamboo Hut. It was just north of the Bon Marche, now Macey's on Third Ave. Laura Lawrence I think was an owner of Seattle Coin. John Drummey is the current owner. The highest membership number to show was # 274 belonging to Jim Bergstrom. I don't recall ever meeting him but many people will remember number 270, Don Elken. Don was a regular at the meetings even though he didn't drive. He passed away just two or three years ago. Junior member number 212 was Gene Henry. He became a dealer while he was in high school and is still very active in the business.

Jack Koch was member 243. He became president of the PNNA and went on to be Executive Director of the American Numismatic Association for a short time.

One of my goals was to have a complete collection of *Numismatist*. A few years ago I was able to acquire a set and by luck it is one that was assembled by Paul Fouts, who apparently sold it to Jack Koch because their names are stamped on the spine of the bound volumes. The early editions carry the name of Paul Fouts and Jack Kochs' name is on a few of the later ones in the 1960's.

PNNA Memorabilia Catalog Updated

Back from the Brink - Aurelian

Most of us who have a knowledge of ancient history hold to the concept of divisions. That is to say that we believe that historical events fall within definite epochs. For example, when considering the history of the Roman Empire we tend to believe that the Western Empire fell in the fifth century followed by the "Dark Ages" and that the Eastern Empire continued on until the mid fifteenth century when it was conquered by The Turks.

I hold to a different concept.

Most historians would agree that the Western Empire didn't fall in the same sense that the Soviet Union did but that it was broken up after a long period of corruption and decay. That the fall was not an event taking place at a point in time, but a breakup as the result of a process. The breakup that we shall look at in this opus didn't occur in the fifth century but in the third.

The mid third century was a time of deep crisis for the Roman Empire. The emperors were concerned mainly with maintaining the loyalty of the armies whom they had to placate with ever larger donatives which put a tremendous burden on the already overtaxed citizens. At the same time, the frontiers were constantly being threatened by barbarian tribes who were steadily gaining strength as the empire became ever weaker. On or around AD 260 the empire faced a double threat. While the armies were contending with the German tribes on the Rhine / Danube frontier, the Persians attacked. This was during the joint reign of Valerian and his son Gallienus. Both emperors took the field and led their armies against Rome's enemies. It was Valerian that went east to meet the Persians. After some initial success the army of Valerian was trapped and the emperor captured alive and later killed. This event sent shockwaves throughout the entire Roman world. Very soon after that, provinces began to break away in order to form separate states that might better provide for their own defense. Spain was lost, Britain and Gaul were lost and in the East, Egypt and Syria were controlled by Queen Zenobia of Palmyra who intended to carve out an empire of her own. Without the resources of the lost provinces and with a greatly reduced territory from which to recruit troops for the legions, the empire was doomed.

Although Gallienus was successful in repelling further barbarian invasions into Roman territory, try as he might, he could not recover the lost provinces. In AD 268 he was assassinated by a group of officers one of whom was the future emperor, Aurelian. In AD 270 Aurelian became emperor and began the campaigns that would restore the Roman world to a condition resembling its former greatness. One after another the barbarian tribes were routed, the usurpers that had broken away surrendered and their provinces brought back under the rule of Rome. The short lived Empire of Palmyra was defeated and Queen Zenobia was brought back as a captive to Rome where wearing golden chains she rode in the Triumph accorded to Aurelian by the Roman Senate.

In domestic affairs, Aurelian reformed the coinage and established a new state religion that was monotheistic in character. The cult of the unconquered son.

As is so true of the events of the third century, the story ends in tragedy and death. It was the intention of Aurelian to wage war against Persia in order to reestablish the province of Mesopotamia. Had he been successful, think of how that would have changed history. Unfortunately, he too was the victim of a plot hatched by his own secretary who had angered him. He forged a list of officers who were to be purged by the emperor and in their fear, struck first and killed him. When they discovered the deception they executed the secretary and appealed to the Senate to appoint a new emperor. Thus ended the career of one of the most competent rulers of a troubled age.

The coin is a double Denarius or Antoninianus as they are called. The reverse shows the figure of the SOL INVICTVS (the unconquered son) standing over a Persian captive.

Minutes of PNNA board meeting

30 April 2005, Tukwila, Washington

The meeting was called to order by President Larry Gaye at 8:06 AM. Present were vice president Richard Billings, secretary/treasurer Joseph Boling, directors Del Cushing, Eric Holcomb, Lisa Loos, Scott Loos, Norm Mikat, William McKivor, William Roark, Kathy Rowe, Larry Rowe, and Bruce Wonder, appointed dealer-director Rob Anglemier, and members George Booth, Mark Emtman, Rick Hobson, Walt Ostromecki, and Bert Simmons, and visitors Prue and Arthur Fitts. Moved and seconded (Wonder/L Loos) to approve the minutes of the previous board meeting (22 January 2005 in Kent). Passed.

President Gaye welcomed visitors Prue and Arthur Fitts, who are here to give numismatic theater presentations and serve as judges.

The North Shore Numismatic Society (NSNS) is producing a medal to commemorate Ray Mah, to be distributed to NSNS members. Presumably some excess medals will be available.

Norm Mikat inquired about whether we have a standing policy for memorial donations. No, they are handled on a case by case basis. Moved/seconded (Mikat/Rowe) that PNNA make a memorial donation of \$100 to the NSNS for their use. Passed.

Larry Gaye gave an update on our recent purchase of associate membership in the Ancient Coin Collecting Guild (with the object of supporting unrestricted international movement of numismatic materials). The ACCG has acknowledged us and the Willamette CC on their web site. Some state legislatures have taken up legislation to support the rights of collectors to collect ancient materials (over 100 years old) that have been the target of restrictive legislation concerning international movements.

Larry Gaye thanked Walt Ostromecki for his work with YNs at this convention. Dr. Ostromecki thanked the PNNA for supporting his nomination for the ANA board.

Bill Roark reported having met the PNNA's adult 2005 ANA Summer Seminar scholarship winner yesterday, and that she is very enthusiastic about the program.

The Willamette Coin Club's bid for an ANA spring show was for joint PNNA/WCC sponsorship, and was accepted. ANA will return to Portland in spring 2009. The committees will be formed shortly; there is a job for everyone.

Marc Bettinger was convicted of theft in Los Angeles (related to his actions at Long Beach last year). He has still not acknowledged his expulsion from PNNA. A discussion of PNNA's obligation to notify members followed. Should the mentions in the minutes be all that we do? Having board members take the information back to club and commercial show committees was deemed to be adequate.

The PNNA/WCC fall show report is that we have sold out three times (we keep adding real estate to the bourse layout). We have sold about 70 tables. A fall show will be a new event, and how it is received is not yet known. We are going back to the Doubletree because we would need to sell about 100 tables to break even if we went to the convention center.

We have been selling out the PNNA convention in Tukwila but we have no place to grow to - the convention center (downtown Seattle over the freeway) is too expensive. Eric Holcomb mentioned a new facility in Lynnwood - we need to check it.

The PNNA is developing a thrust of performing the educational component of shows primarily put on by local organizations. PNNA will be doing this at the fall show in Portland, and has been requested to support the Salem club at their 50th anniversary show (fall 2006).

George Booth expressed thanks to Scott and Lisa Loos for their work on this show.

New business - Eric Holcomb proposed that officers be reimbursed for driving on behalf of the PNNA. He requests the IRS's commercial rate for driving for specific tasks (such as pickup up or delivery of calendars, *Nor'Westers*, etc), and the non-profit rate for simply attending PNNA events as an officer. Joseph Boling opined that he felt such expenses should deducted from an individual's taxes or considered as a donation as a volunteer for the organization. The sense of the board was that Eric should put his proposal in writing for consideration at a future board meeting. He agreed to do so.

There being no further business, the meeting adjourned at 8:57 AM.

Minutes of PNNA general membership meeting 30 April 2005, Tukwila, Washington

President Larry Gaye called the meeting to order at 6:25 PM. Twenty-one members were present.

The first business was announcement of the fall show in Portland (28-30 October) jointly sponsored by Willamette Coin Club and the PNNA, with the WCC running the bourse and the PNNA conducting the educational programs. The show will be at the Doubletree Inn (where the PNNA annual show was held from 1995-2000). Part of the proceeds from the show will fund a scholarship to the ANA summer seminar in the name of Rob Retz.

The ANA board, meeting in Kansas City in March, decided that the ANA will return to Portland for its spring National Money ShowTM in 2009.

As of 2:00 PM on this date, attendance at the PNNA convention in Tukwila, 2005, had been about 1,200 persons.

President Gaye thanked Dr. Walt Ostromecki for his work in administering the YN program at this convention. About 500 YNs took part in the program. He then thanked Arthur and Prue Fitts for their presentations in the numismatic theater at this convention. Bruce Wonder pointed out that some local clubs are coming up on their 50th anniversaries. Salem will celebrate its 50th in 2006, and the Vancouver Numismatic Society's 50th was this month (for which a commemorative medal has been struck). Victoria will celebrate theirs 12 June.

Lisa Loos announced the winners of the PNNA scholarships to ANA summer seminar for 2005 - adult Janna Silverstein and YN Matthew Crane.

Larry Rowe thanked the exhibitors at the convention [way too few] and the judges (Joseph Boling, Arthur and Prue Fitts), and announced the following exhibit awards:

Competitive exhibit award winners:

Class 3, tokens, medals, and decorations: 1st place, J Eric Holcomb (space program medals). Class 5, miscellaneous: 1st place, Susan Billings (AA program medals).

Clarence Heppner award, best tokens and medals exhibit - J Eric Holcomb. Byron Johnson award, best of show - J Eric Holcomb (this includes \$200 in assistance to take the exhibit to the 2005 ANA convention).

President Gaye thanked Larry Rowe for his service as exhibit chairman.

President Gaye announced that the Bob Everett award for 2005 goes to Joseph Boling (certificate and a check for \$200).

President Gaye thanked this convention's general chairman (Richard Billings) and bourse chairman (Scott Loos) for their work.

President Gaye announced that the Nina Nystrom Numismatic Ambassador award for 2005 goes to Lisa Loos and Scott Loos (plaque).

Arthur Fitts stated that he and Prue had come because the Rowes and Loos' had invited them. It had been a fun convention, and they see a vitality here that is missing in many other locales.

Eric Holcomb announced that there would be leftover copies of *The Nor'wester* if anyone needs them for local distribution at their home clubs.

Someone suggested that in future years there should be a security room for non-local dealers on Thursday evening. The committee will consider that, but is not optimistic that we will spend the money to support that suggestion.

The meeting adjourned at 6:53 PM.
