# ANA Worlds Fair of Money® 2009 – LA Report by Larry Gaye

I always enjoy going to the ANA shows. The Los Angeles ANA was a very different experience for everyone. It was the first show the ANA has charged the general public an admission fee. Numbers were certainly down though I'm convinced it wasn't the fault of the fee; just the fact that so many locals won't go to downtown LA. The show was held at the LA Convention Center, an excellent venue especially for those involved in the set up of the convention. A three day Jonas Brother's engagement at the Staple Center created gaggles of screaming female tweens that had to be negotiated by all.

The visitor/membership sign-in process was totally different from what we all had become used to. Because of the new entry fee, separate lines and kiosks were needed for existing members, newly signed up members, and the general public. For the first time monies had to be collected for admission fees. The whole process was a challenge that the National Volunteers and ANA staff did a masterful job of accomplishing.

While the ANA charged the general public \$6.00 per day per person (kids were free) it offered an introductory ANA membership for \$18.00 per year. With that membership program there is no printed copy of *The Numismatist*, only the online version. A special 13th copy of *The Numismatist* was printed to act as the show directory and program which everyone who attended received. It was an excellent way to showcase what the ANA has to offer collectors. I have kept mine as a collector's item; I have programs from all ANA shows since 1997.



The weather was great; for gosh sakes, its Southern Suz-California! anne and I had one event we signed up for to the La Brea Tar Pits cancelled due to lack of interest, imagine that? So we called a cab and went on our own; it was a fantastic experience. The cabby was a LA

Native and gave us a private tour of points of interest on the way to the Pits. We made arrangements for him to pick us up when the park closed and he was right on time and well tipped. We found a really nice restaurant which we visited several times. It featured great Mediterranean style food at reasonable prices, a great wine selection, and a dynamite staff. We felt right at home and turned a lot of folks on to it.

## **Board of Directors Meeting Minutes**

Date: October 24, 2009. Time: 6:15 p.m.

Location: DoubleTree Lloyd Center Hotel, Portland, OR.

Members Absent: Steve Cox, Director; Craig Korstad, Director; William McKivor, Director; Michael Sanders, Director; David Ownbey, Director.

Guests in Attendance: Richard Billings; J a m e s , Beth and Katie Reinders; Robert Steinegger.

The board meeting was called to order by President Lisa Loos at approximately 6:15 p.m. Lisa welcomed the directors and introduced guests, who are noted above.

Mike Labosier called for any changes or corrections to the minutes of the August 22, 2009 board meeting as published in *The Nor'wester*. No changes were reported and the minutes were approved (Scott/Danny). Mike then reported that the PNNA's club ballot for ANA Officer and Governor positions had been voted in favor of Cliff Mishler (President), Joe Boling, Walt Ostromecki and Tom Palmer (Governors). The PNNA board had supported the nomination of these candidates and approved voting the club ballot for this slate via email vote concluded on June 18, 2009.

Scott Loos presented the Treasurer's report. Club revenues for the first nine months of 2009 totaled \$45,434 and expenses were \$49,863. At September 30, the club held cash balances of \$56,431, mostly in CDs and a money market account. The Treasurer's report was accepted by the board (Del/Mark). Scott also reported on the club's general liability insurance coverage. A discussion followed regarding the appropriate level of coverage and additional insurance considerations relating to club sponsored shows.

#### Old Business:

Lisa reported on the membership flyers that were distributed at the Puyallup Fair. She is continuing to work with Rob on a new tri-fold flyer, which they plan to have ready for the Boeing show in January, 2010.

#### Committee Reports:

Education – Scott discussed his efforts to explore educational offerings the PNNA could provide or sponsor. The ANA program that was under consideration is

not currently available. Danny had solicited opinions among the mid-Oregon clubs and found resistance to fees over \$100. Given these developments, the PNNA will likely need to consider educational programs it can offer on its own.

Publication – Eric presented a memo regarding the PNNA website that he had emailed to the board members prior to the meeting. He explained his decision to migrate all PNNA web pages from Microsoft Front-Page to Microsoft Expression Web software. Eric then described improvements to the website he planned to implement and other enhancements the board may want to consider. Possibilities such as more advanced interactive features and various web hosting options were discussed. Eric's presentation concluded with a proposal that the PNNA contribute \$500 toward website costs in exchange for Eric's agreement to provide website design and update services, along with newsletter editing services to the PNNA, for a period of at least three years at no additional cost. A motion to accept this proposal was approved by the board (Del/Bruce).

Outreach – Lisa reported for Greg Smith on the success again this year of our participation at the Puyallup Fair's Hobby Hall. The PNNA booth was busy with many visitors. Lisa continues to pursue a volunteer for the YN Coordinator role. James Reinders noted that he had worked with seven Scouts on Saturday at the PNNA Fall Convention. The board thanked James, Beth and Katie Reinders for running the YN activities at the convention in Walt Ostromecki's absence. Walt was unable to attend due to illness.

Membership – No report beyond progress on the membership flyer discussed by Lisa earlier.

Exhibits – Eric reported that there were no competitive exhibits at the PNNA Fall Convention.

Election – Lisa presented the election committee report on behalf of Bill McKivor, who was unable to attend the meeting. The ballot for the 2010 PNNA Board of Directors election will be posted in the first quarter 2010 edition of The Nor'wester. {It now appears that the ballot and candidate biographies will appear in either a special Febraury mailing, or the convention edition of *The Nor'wester* due out in March.} Current board members were asked to contact Bill, Mike Sanders or Mike Labosier to indicate whether or not they intended to run for another term. Those who will be standing for election were asked to prepare brief biographies for publication with the ballot. It is hoped that providing background information on the candidates will increase membership interest in the election and improve voter turnout. Del announced that he would be retiring from the board after 29 years of service. {Thank you, Del.}

Convention – Larry gave a brief report on the first day of the PNNA Fall Convention. Dealer tables were sold out. As of Saturday, the show had attracted over 400 attendees. Mike Labosier and Scott will meet sometime in December or January to begin planning for the April 2010 PNNA convention in Tukwila.

Awards – Danny presented the 2009 Bob Everett Memorial award to James Reinders.

Other Business – Larry noted the ANA's continuing interest in Portland as a site for its national conventions. The 2009 ANA National Money Show<sup>TM</sup> was viewed as a big success, with 8,000 visitors over the three day event. The ANA will be expanding its spring show to four days from three, and Portland is likely to be a frequent contender for future spring shows. Larry exhorted those in PNNA and Willamette Coin Club leadership positions to be prepared to step up to the opportunities that may arise.

There being no further business, the board approved a motion to adjourn at 7:15 p.m. (Del/Mark).

## When Does A Coin Become History?

One of the real joys of coin collecting is finding a coin that truly qualifies as a piece of history. Another is finding a bargain! So, one can easily claim that when you have found one coin that satisfies both of these, you have really hit the jackpot. Let me relate a story of a find that might have done this – possibly.

At a smaller show recently, I came across a dealer who was new to me. He sold a mix of both United States and world coins, and had a couple of different bargain boxes on his table, which he had sorted by price. A large sign in front of the bargain boxes proclaimed that everything was 25% off the lowest listed price, and the dealer greeted me kindly. I sat down and started to chat, and at the same time took a look through these rather heavy bins. After a few minutes of rummaging through German pfennigs, French francs, Italian lire, and other such twentieth century pieces (with the occasional 1890's coin thrown in) I noted close to the bottom of one bin a 1972 Bicentennial Commemorative Medal, still housed in the plastic capsule and plastic case in which it was originally sold. Believe it or not, the fold out flyer explaining the Houdon bust of George Washington, the Liberty Tree, the Stamp Act, and the expression "Join Or Die" was still inside the case, and still in excellent shape. What was the price on this thirty seven year old offering of the United States Mint? Well, \$1.50, before the 25% discount. Amazing, I thought to myself.

I held this piece for a while, examining it again in detail, and a flood of memories came rushing back. While I'm not the most "chronologically superior" of collectors, I am far removed from my days as a young numismatist as well. This medal took me back to the years when I started collecting seriously - meaning I moved from simply gleaning coins out of change to setting aside some money to pay for the ones I wanted. Long before the internet, the Mint sent out announcements a few times each year advertising the numismatic items they had for sale. This bicentennial medal was one of the first items to commemorate that event. After all, the actual bicentennial was still four years away! But the medal caught my attention, in part because it was one of what seemed to be many medals in different metals, that would be part of any upcoming bicentennial celebration. I also seem to remember that the price for this particular medal was \$5, which I thought of as a handsome sum at the time.

Now, even if my recollection is wrong, this medal had to have cost more than \$1.13 (the \$1.50 less the discount) back when the Mint was selling it. So, what gives? Have these medals become the poor relation of

all coin collectors, or did this one dealer just end up being a nice guy? Shaped in a larger framework, the question becomes: when does a coin (or a medal in this case) become historic? When is an item old enough that it becomes a prize collectible?

Well, if you listen to the persuasive folks on the shopping network channels, each and every quarter they sell will rapidly become a historic numismatic item of great value. If you are somewhat more cynical, you'll recognize that centuries, or even millennia, sometimes have to pass before a coin or medal becomes historic. Proof of that would be any coin of the Roman Empire that today costs \$10 or less. Likewise, there are a few worn issues from some of the Greek City states that can be purchased for about the same price. But this bicentennial medal, with its rather Roman-looking portrait of President Washington, apparently has not yet made it to the ranks of the coveted numismatic treasures, at least not if the price is so very low.

All that being said, though, a bicentennial medal like this takes a person back a bit, to something of a different time in numismatics. The Mint was out of the commems business, and apparently Congress was too. That's tough to believe today, what with circulating commemoratives galore, as well as a pile of collector's issues with different themes each year. But that's the way it was then, in 1972, when as a nation we were far more concerned with pulling troops out of a war in Viet Nam, or with landing men repeatedly on the moon. Holding this one bicentennial medal brought all the memories back, and I realized that even if this wasn't historical now, it was becoming so.

There are supposedly some languages in which the concept of a person being "dead" can only be expressed in two different ways. There are the immediate dead, such as a mother or father, who are remembered by those still living. Then there are the farther past dead, such as George Washington, or Thomas Jefferson, who no one remembers personally, but who are remembered collectively. Holding this medal made me wonder if perhaps numismatics would benefit from some similar set of ideas. There would be the coins we know from personal experience that have changed history, such as Delaware quarter of 1999, or the golden, Sacagawea dollar. The real firsts. Then there are the historically important coins, such as the Fugio cents, the 1856 flying eagle cents, or the first United States silver dollars, that no one alive today remembers being minted, but that we all consider important.

While such a delineation may never make it into our language or our hobby, it's still rather impressive what comes to mind upon simply finding a bicentennial medal for \$1.50. {See photos on page 6.}


